HOW TO LEAVE A GIFT IN YOUR WILL TO THE OPERA AUSTRALIA CAPITAL FUND

Some general guidelines

- Of course, family and friends will be your first priority discuss your plans for your Will with them
- Seek independent legal advice about your particular circumstances so that your Will is drafted in a way that ensures your wishes are met
- General or unrestricted gifts in Wills are especially valuable as they allow your gift to be directed to Opera Australia's areas of greatest need
